An 8-year-old boy and his then 9-year-old sister disclose to their Russian mother and her partner how they suffered from their UK father as the leader of a Satanic Ritual Abuse (SRA) cult:

- 20 children and some 70 adult abusers, including parents, teachers, clergy, Social Services, Police
- Eight schools and a church in the Hampstead area of London.
